Important Notes

1. Must be done on a Declaration form. See sample copy attached.
2. Postage stamps to the value of \$1.50 MUST be placed on each declaration form for it to be valid.
3. The form MUST be signed & stamped by a Justice of Peace. The Justice of the Peace cannot provide declaration and then sign as JP simultaneously.
4. Three (3) affidavits are required and they MUST be from 3 different persons.
5. Of the three affidavits, one declarant MUST be serving/have served as the principal/vice principal at the time of the employment period.
6. The employment period must be specific and state day, month & year.
7. There is no need to include any additional words or phrases other than what the sample affidavit outlines.

Important Notes

1. Must be done on a **Declaration form. See sample copy attached.**
2. Postage stamps to the value of \$1.50 **MUST** be placed on each declaration form for it to be valid.
3. The form **MUST** be signed & stamped by a Justice of Peace. The Justice of the Peace cannot provide declaration and then sign as JP simultaneously.
4. Three (3) affidavits are required and they **MUST** be from 3 different persons.
5. Of the three affidavits, one declarant **MUST** be serving/have served as the principal/vice principal at the time of the employment period.
6. The employment period must be specific and state day, month & year.
7. There is no need to include any additional words or phrases other than what the sample affidavit outlines.
