### Request for Bids (RFB)

#### Belize - Skills for the Future Program

#### Rehabilitation of the existing ITVET Building, including Furniture NCB/2.3.2/2.3.5.1/2025

1. This RFB follows the General Procurement Notice for this Project that appeared in the Inter-American Development Bank, 23 May 2023.
2. Belize *has received* a loan from the Inter-American Development Bank toward the cost of the Skills for the Future Program, and it intends to apply part of the proceeds of this loan to payments under the Contract for *Rehabilitation of the existing ITVET Building, including Furniture – NCB/2.3.2/2.3.5.1/2025*.
3. The Government of Belize, acting through the Ministry of Education, Science and Technology, now invites sealed bids from eligible and qualified bidders for *the Rehabilitation of the existing ITVET Building to house the new ITVET course offerings and the supply of furniture for the classrooms*, located at the ITVET Compound, Belize City. The delivery/construction period is nine (9) months.
4. The RFB will be conducted through the National Competitive Bidding (NCB) procedures specified in the Inter-American Development Bank's *Policies for the Procurement of Goods and Works, financed by the Inter-American Development Bank GN-2349-15*, and is open to all bidders from Eligible Source Countries as defined in the bidding document.

  - *Construction equipment as listed*
  - *Key personnel as listed*
  - *Reports on financial standing for the past 3 years*
  - *Evidence of adequacy of working capital*
  - *an average annual billing of construction work over the period specified below, of at least the multiple (of the estimated value of the*
